Grace + Peace be unto you in the name of the One who has poured forth God's own Spirit upon all the earth, even the same Jesus Christ our Savior and Lord!

Great is the faithfulness of our God! As the above quote from the hymn, "Great is Thy Faithfulness" reminds us, our God never tires of grace. Our God never tires of caring for us. Our God never tires of offering us forgiveness and life eternal. Our God never tires...not even in a pandemic.

With the beginning of the Season of Advent we find ourselves on the threshold of a new church year. REPORT OF THE ARCHIVES AND WEBSITE

Although it complies with the latest security requirements, it is not "responsive" which means it does not do well on a phone or other small screen device. Efforts to secure a quote for revisions were not successful, but it is a project for consideration in 2023.

**REPORT OF THE
CONSTITUTION REVISION COMMITTEE**

The ad hoc constitution committee was appointed by the Congregation Council to review and propose revisions to St. Mark’s Constitution. The committee members—Ralph Zeigler, Pam Jensen, Candy Dewar and Gary Weber—met approximately 9 times between August 2021 and April 2022.

The background is that the congregation last updated the constitution in 2018, and there were major changes at that time because it had been 28 years since the last revision. The focus at that time was to incorporate St. Mark’s procedures into a new more comprehensive format required by the Synod. Existing procedures were carried over unchanged.

This time, the committee took a line-by-line look at church procedures, evaluated whether actual practice followed constitutional requirements, determined whether the language will work for us in the future and recommended a number of changes in the document. The committee also corrected a serious oversight – although by-laws are mentioned many times in the constitution, no by-laws existed.


The resulting product is a revised constitution that corrects and updates our constitution, eliminates unnecessary language, and provides a more concisely written and understandable document. And by-laws were developed!

The draft was approved by Council, and once by the congregation. A required second approval by the congregation is being sought at the annual meeting on December 4, and the Bishop must approve, but it is hoped to implement the revisions in 2023.

Since 2020 the pandemic has greatly restricted the activities of the Parish Life Committee. But 2022 saw a lessening of restrictions in the community and at St. Mark's. Parish Life rejoiced at the prospect of once again serving others in the name of our Lord.

Our activities within the congregation included

- Serving several funeral luncheons when asked by the families to do so.
- Providing hospitality for church events when requested.
- Replacing or servicing kitchen appliances in anticipation of increased activities. A new refrigerator was purchased, the ice maker and all three stoves were serviced and repaired as needed.

Our activities for the community included

- Catering the monthly luncheons for the Center City Pastors of the United Churches of Lycoming County.
- Providing twenty-four sandwiches twice per month to New Covenant UCC's Blessing Boxes.
- Assisting the Evangelism and Fellowship Committee with providing and packaging desserts for Redeemer's community dinner.

- Continuing with all the activities from this year and looking for opportunities to further serve the congregation and the community as we are able.



REPORT OF THE SAFETY COMMITTEE

The goal of the Safety Team is to provide Safety and Security to the St. Mark's Congregation as well as being First Responders in a medical emergency until the Ambulance arrives.

The team members are: Dr. Drew Haussmann (Chairman), Sally Bjornstad (Secretary), Herb Poff, Dave Williams, Walter Doebler, and Pastor Vasey.

At the end of September, 2021, Council voted to purchase an AED, Auto External Defibrillator. In January, 2022, Dr. Haussmann gave an AED inservice in which 10 people attended. He opened the AED and thoroughly explained how it works. He explained to us this unit is for sudden cardiac arrest and is designed to be used by anyone. You do not need to be a medically trained person. The machine talks you through it. Besides the AED, 911 is to be called immediately and CPR is to be administered until the AED indicates use or the Ambulance arrives.

In February, 2022, Carl Albright resigned as Chairman of the Safety Team. The team would like to thank Carl for his service. He did so much for our team. Dr. Drew Haussmann graciously agreed to be our new Chairman in April and in May 2022, we had our first meeting. The team is so blessed to have Dr. Haussmann as our Chairman.

Since then, signs have been made for the location of the AED and First Aid Kits. We are in the process of putting them through-out the Church. In May, 2022, the Safety Team had a refresher course in the use of the AED by Dr. Haussmann.

Then we turned our attention toward the Fire Extinguishers. The Fire Extinguishers were inspected by Fry's Fire Service in July, 2022. In order to expand the safety of St. Mark's, we are purchasing two additional ones and relocating a third one. Small signs will be put above the light switches through-out the Church to tell the location of all the extinguishers.

Looking ahead, we are contacting a Security Co. to give us a quote on how much it would cost to have every exterior door checked each night everyday to be sure they are locked and secure. Also, a sign will be made for the Fellowship Hall doorbell which will indicate to go to the Office door if no one responds to the bell. Office hours are M-F 9am-1pm.

Our outreach within the congregation included

- Continuing to send greeting cards to our Special Concern folks and others we do not see as often as we wish. Cards were sent at Christmas, Valentine's Day, Easter, July Fourth and Thanksgiving.
- Continuing the Card Ministry which was reestablished in 2021. In addition to our committee members, congregation members send cards, on a rotating basis, to our Special Concern folks to honor birthdays, anniversaries, thinking of you or get-well greetings as another way to stay in touch.
- Assisting the Faith Formation Committee in various activities throughout the year.
- Continuing the creation of Welcome mugs begun by the Dancho's.
- Hosting our missionary to Liberia, Linda Johnson Seyenkulo, in July.

- Hosting two blood drives in Fellowship Hall in partnership with the American Red Cross.

The purpose of the Property Committee is to proclaim Jesus Christ to each other and all the world by promoting the use of the congregation's physical resources in the support of our Christian Mission. To this end the committee arranged for the promotion, protection, maintenance, repair and expansion of church properties. The Committee supervises the use of the same by the congregation and other organizations so that the facilities are adequate for the functions assigned by the congregation.

The year 2022 brought significant change to the property committee. In addition to the challenges posed by the ongoing COVID-19 pandemic, we have also lost our long time sexton, Lou DeSeau. Lou was known and appreciated by everyone in the congregation, and he not only knew everyone within the parish, but also everything there was to know about the property and infrastructure that is St. Mark's. There is no replacing a person like Lou, but the building and grounds still need to be cared for and maintained. As the committee awaits the hiring of a new sexton, they have worked together to tackle the problems and maintenance needs of the building and grounds that have arisen throughout this past year.

Drew Haussmann has stepped up to join Ed Gair as chairperson, filling Lou's role as previous co-chair of the committee. Many of the routine cleaning tasks of the church are now being attended to by Choice Cleaning, though the committee would like to make a special mention and thanks to committee member, Dr. Carl Albright, who is frequently tending to a variety of cleaning tasks as well as leading the "outdoor crew."

The purpose of the Finance Committee is to proclaim Jesus Christ to each other and to our community by prayerfully managing the financial resources of the congregation.

The St. Mark's Finance Committee faced many challenges this year, including the retirement of Jackie Kinney as Treasurer and of Jackie Baysore as Bookkeeper. Our heartfelt thanks to both Jackies for their tireless and invaluable contributions to the financial stability of our congregation.

Since the last financial audit of St. Mark's was conducted in 2019, Larson Kellett was hired to perform an audit for the period of July 1, 2021 - December 31, 2021. We received excellent feedback and only minor suggestions for improvement.

A subgroup of the Finance Committee met with Chris Fellon, our insurance representative from Brotherhood Mutual, and performed a thorough review of our insurance policy. This led to a plan to bring in the Industrial Appraisal Company to conduct a comprehensive insurance appraisal of St. Mark's building and assets, since the last such appraisal was done several years ago.

For some years, there have been concerns as to what would happen with payroll if there were to be a disruption in bookkeeper service. With Jackie Baysore's retirement, those concerns became reality and Council voted to hire MinistryWorks to provide payroll services to St. Mark's, beginning in January 2023.

On November 3, we welcomed Deb Kershner as our new bookkeeper. Deb has over 30 years experience with administrative tasks, including billing, payroll, tax returns, and office management. Deb will work 8 hours per week, Monday and Wednesday mornings.

Our proposed budget for 2023 will be presented to the congregation at the annual meeting on December 4, and is found at the end of this report.

None of this work could have been done without the help of Finance Committee members Diane Bardsley, Wanda Fortin, Jackie Kinney, Herb Poff, Barb Thomas, Phil Thomas, Gary Weber, Ralph Zeigler, and Pastor Vasey. UPDATE ON DOSSAL REPLACEMENT PROJECT

Dossal Replacement: An Update

Replacement of the dossal cloth behind the altar was discussed at the February 2020 Council meeting when the family of a long-time member of St. Mark's was looking for a possible memorial gift. Council members (and others) noticed that the current white dossal cloth was becoming noticeably dirtier and, in some places, torn; it needed to be addressed.

At that meeting, Council approved using red fabric when the dossal was replaced again. This was the color originally chosen by the award-winning architect who designed our church, T. Norman Mansell. It adds some warmth to the chancel and offsets the coolness of the two larger grey screens (one on either side of the dossal) on which the wooden plaques are hung.

Then the pandemic arrived in March 2020, and everything was put on hold.

Even though we still are in earlier stages of the dossal replacement project, some progress has been made. The current dossal cloth is made up of 21 panels that together create a white backdrop for the suspended cross. The area is approximately 11 feet wide x 36 feet high. It features two multi-color orphreys or bands, one on either side of the dossal. One plan would be to replace the current fabric with red cloth and to re-install the frames.

A second plan would be to revert to the architect's original design, that of a continuous red cloth from ceiling to floor. Many of the fabrics used for dossal cloths come in widths of 55 to 60 inches. Three sections of fabric would be sewn together to create a single red dossal, taking careful measures to align any patterns in the cloth. Mr. Mansell chose blue as the color for the original two orphreys.

To date, the Worship and Music Committee has looked at several different red fabrics. There are some lovely choices. We know that the cost per yard can range between \$75 and \$125 or more.

Based on these known figures, we estimate that the cloth alone most likely will cost between \$3,000 and \$5,000. Also, there will be other costs including labor involved in sewing and the orphreys that adorn the sides of the dossal.

Currently, we are researching installation options and working to find a company to do this complex work. Those costs may not be known for a while. However, as that information becomes available, we will share it with the congregation.

St. Mark's is blessed to have a beautiful worship space. Our nave was thoughtfully designed more than 60 years ago and continues to serve us well. The Worship and Music Committee is being deliberative as it seeks ways to assure that our facility retains its splendor. We appreciate your patience and understanding, as well as your thoughts and support.
